STAFF BRIEFING:

- The City of La Marque conducted a General Election on May 1, 2021, to elect a Mayor, a Councilmember for District “C” and a Councilmember for District “A”.
- After receiving all of the election returns, Keith Bell was elected for Mayor for a three-year term; Michael Carlson was elected as Councilmember for District “C” for a three-year term.
- Of the candidates for District “A”, no one received 50.1% of the total votes, so according to the City’s Charter, a Run-off Election was necessary and such election took place on June 19, 2021, between the two candidates with the highest amount of votes (Kimberley N. Yancy and Wayne Hobgood)

HISTORY:

- According to the City Charter, officials are elected by majority vote.

May 1, 2021 - Conducted the City of La Marque General Election

June 19, 2021 - Run-off Election for District “A”
