

- a. Discussion/possible action regarding status of started Parks Board Projects (Back up to be provided at meeting.)
Ms. Hobby stated it would be an estimated cost of 40,000 dollars just to stabilize one side of the shoreline. Ms. Hobby will need to get one more quote before budget. The permanent solution of stabilizing the shoreline would be an estimate of 800,000 dollars. Next month's meeting will include the process of what stabilizing the shoreline consists of from the Engineering company. Board Member Griffin asked when will the Board be able to present their budget to Council and Ms. Hobby stated, "August."

(9) **NEW BUSINESS**

- a. Discussion/possible action regarding the feedback of the Park Master Plan public meetings.
Ms. Hobby stated there were a lot of opinions from the public. One child drew out plans and showed what she wanted at Westlawn and other surrounding parks in the City. Westlawn was the biggest turn out. Board Member Franklin asked about the complaint someone made at Westlawn, cutting the bushes? Ms. Hobby sent to Charlene to get ahold of the contractors who is responsible for maintaining those. Board Member Griffin says there is very limited information about each park and the community wanting to be more involved with the Parks. The awnings will be painted next week by the contractors. Board Member Bock spoke to the Lieutenant of Wildlife and he stated that whoever we get to kill the hogs have to follow the guidelines for hunting and concealed weapons ordinance and get the Chief of Police to sign off on it. Ms. Hobby stated she will get with Tink and go from there.
- b. Discussion/possible action regarding marketing including, social media, park history, and Website.
Board Member Griffin says there is only a Facebook page for the Parks, and it is for Highland Bayou Park and Mahan. There are no pictures on the City's website of the City Parks. Board Member Williams says she believes it is Colleen that is responsible for handling the social media and City website for the City. Board Member Bock suggests adding a complaint link to the Park page on the City's
