**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LA MARQUE, TEXAS,
AWARDING BID LM #03-23 FOR WATER AND SEWER MATERIAL PURCHASES;
AND AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AND ALL
DOCUMENTS NECESSARY TO EFFECTUATE AN AGREEMENT FOR SUCH
SERVICES; PROVIDING FOR THE INCORPORATION OF PREAMBLE; AND
PROVIDING AN EFFECTIVE DATE.**

WHEREAS, the City of La Marque requires a contractor to provide materials for water and sewer maintenance of pipelines; and

WHEREAS, the City of La Marque advertised for Water and Sewer Materials on Wednesday, August 24, 2022, and Wednesday, August 31, 2022, in the Galveston Daily News; online via City Website Bids Page; and

WHEREAS, two proposals were received by 10:00 a.m. Wednesday, September 7, 2022, in response to LM #03-23; and

WHEREAS, upon full review and consideration of the Evaluation Summary for LM #03-23, herein attached as Exhibit 'A' and all matters attendant and related thereto, the City Council is of the opinion that LM #03-23 should be awarded to Core and Main and that the City Manager should be authorized to execute an Agreement for the services.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LA MARQUE, TEXAS, THAT:

Section 1. The facts and matters set forth in the preamble of this Resolution are hereby found to be true and correct and are incorporated herein and made a part hereof for all purposes.

Section 2. The Evaluation Summary for LM #03-23, having been reviewed by the City Council of the City of La Marque and found to be acceptable and in the best interests of the City of La Marque and its citizens, are hereby in all things awarded.

Section 3. The City Manager is hereby authorized to execute an Agreement and empowered, for and on behalf of the City, to take all such actions and to execute, verify, acknowledge, certify, file and deliver all such instruments and documents required in the Agreement as shall in the judgment of the City Manager be appropriate in order to affect the purposes of the foregoing resolution and Agreement.

Section 4. This Resolution shall become effective immediately upon its passage.
