By completing the application below, I agree to the following requirements by Keep La Marque Beautiful Commission and City of La Marque:

- I own and reside in the house at the address listed below located within the City of La Marque and it is not used as rental property;

- I understand that I am not eligible for this program if I have any active City Code violations on my property, including but not limited to high grass and weeds, junk vehicles, or accumulated garbage;
- Paint is being requested and will be used only for the property on my application;

- I understand all repairs, including roof and wall repairs, and preparation of the house for painting must be complete at the time this application is submitted;
- I understand that the City of La Marque is not responsible for any injuries I sustain while painting or performing any other work on my property and that I should take precautions or hire a professional as needed for my specific health, age and experience level;
- I understand paint in certain colors will be available free of charge, but preparation of the house for painting, labor, and other supplies will be my sole responsibility;
- I understand that I must use the voucher provided to me free of charge by August 27, 2021, and that I must complete painting of my house by August 31, 2021; and
- I understand that I am required to provide proof the residence was painted by emailing pictures of the painted residence to e.childs@cityoflamarque.org or dropping them off in the Utility Billing window at City Hall in an envelope marked "Paint the Town Program" and including my address.

I understand that my statements are subject to verification. I will report immediately any changes in the information given and will notify the City of La Marque Code Compliance Department immediately if I am unable to complete painting of my house by the deadline.
